This is a summary of the annual report for the INSURANCE AND BENEFITS TRUST OF THE PEACE OFFICERS RESEARCH ASSOCIATION OF CALIFORNIA SAFETY PLAN, (Employer Identification No 68-6068469, Plan No. 501) for the period beginning January 1, 2017 and ending December 31, 2017.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

SELF-FUNDED BENEFIT INFORMATION

The Trust maintains long term disability and death benefits under a self-funded program.

INSURANCE INFORMATION

The following brief description of the Trust benefits are provided for general information purposes only. Participants should refer to the Trust document for more complete information.

The Trust has contracts with Standard Insurance Company to pay long term disability and life insurance claims, with ReliaStar Insurance Company for life insurance and AD&D. The total insurance premiums charged to the Trust for the year ended December 31, 2017 were \$3,074,936. Of the total insurance premiums paid for the plan year ending December 31, 2017, the premiums paid under such "experience-rated" contract were \$2,262,267 and the total of all benefit claims paid under the experience-rated contract during the plan year was \$2,798,975.

BASIC FINANCIAL STATEMENT

Benefits under the Trust are provided by the Trust and insurance. Trust expenses were \$6,484,309. These expenses included \$1,576,441 operating expenses, \$16,128 in investment expenses, \$1,816,804 in benefits paid directly to participants and beneficiaries, and \$3,074,936 in insurance premiums charged by insurance companies and a health maintenance organization.

The value of Trust assets, after subtracting liabilities of the Trust, was \$4,531,466 as of December 31, 2017 compared to \$3,078,257 as of January 1, 2017. During the Trust year the Trust experienced an increase in its net assets of \$1,453,209. This increase includes unrealized appreciation or depreciation in the value of Trust assets; that is, the difference between the value of the Trust's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year.

The Trust had total income of \$7,937,518. This income included participant contributions of \$5,678,954, gain on investments of \$358,003 and other income of \$1,900,561.

If you request a copy of the full annual report from the Contract Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
