This is a summary of the annual report for the INSURANCE AND BENEFITS TRUST OF THE PEACE OFFICERS RESEARCH ASSOCIATION OF CALIFORNIA SAFETY PLAN, (Employer Identification No 68-6068469, Plan No. 501) for the period beginning January 1, 2018 and ending December 31, 2018.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

SELF-FUNDED BENEFIT INFORMATION

The Trust maintains long term disability and death benefits under a self-funded program.

INSURANCE INFORMATION

The following brief description of the Trust benefits are provided for general information purposes only. Participants should refer to the Trust document for more complete information.

The Trust has contracts with Standard Insurance Company to pay long term disability and life insurance claims, with ReliaStar Insurance Company for life insurance and AD&D. The total insurance premiums charged to the Trust for the year ended December 31, 2018 were \$5,576,557.

Standard Insurance Company is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2018, the premiums paid under such "experience-rated" contract were \$4,920,907 and the total of all benefit claims paid under the experience-rated contract during the plan year was \$2,932,871.

BASIC FINANCIAL STATEMENT

Benefits under the Trust are provided by the Trust and insurance. Trust expenses were \$8,452,675. These expenses included \$1,692,085 operating expenses, \$48,659 in investment expenses, \$1,135,374 in benefits paid directly to participants and beneficiaries, and \$5,576,557 in insurance premiums charged by insurance companies and a health maintenance organization.

The value of Trust assets, after subtracting liabilities of the Trust, was \$5,998,538 as of December 31, 2018 compared to \$4,531,466 as of January 1, 2018. During the Trust year the Trust experienced an increase in its net assets of \$1,467,072. This increase includes unrealized appreciation or depreciation in the value of Trust assets; that is, the difference between the value of the Trust's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The Trust had total income of \$9,919,747. This income included participant contributions of \$8,085,090, losses on investments of \$303,676 and other income of \$2,138,333.
