Dear Member:

We hope you are doing well during these difficult and challenging times. Over this past year, the Insurance and Benefit Trust of PORAC (I&B Trust) instructed our Broker/Administrator, Myers-Stevens & Toohey to issue a RFP concerning our Group Long Term Disability (LTD) program, which has been for many years underwritten by The Standard Insurance Company. After an extensive analysis the I&B Trust is pleased to announce that as of April 1, 2021, MetLife (Metropolitan Life Insurance Company) will be our new insurance carrier for the I&B Trust of PORAC Group Long Term Disability plan. What does this change in carrier mean to you?

- Your coverage will be transferred to a policy that closely matches your current coverage using MetLife's provisions, definitions, filed language and forms. You do not have to reapply.
- Coverage with The Standard will end March 31, 2021, unless you are currently on a
 disability claim. MetLife will be responsible for all claims incurred on or after April 1, 2021.

- You will receive from Myers-Stevens & Toohey a new MetLife certificate to replace the current certificate you have with The Standard after April 1, 2021.
- Enhanced benefits.

Plan Enhancements

MetLife's plan offers enhancements that you will not find in your current policy through The Standard. Some of the enhancements include:

- Extended Maximum Benefit period beyond age 65 based on the Social Security Normal Retirement Age (SSNRA);
- \$400 monthly expense for family care while participating in a rehabilitation program;
- Reimbursement for moving expenses while participating in a rehabilitation program;
- Increase in benefit to 100% for 12 months, for a terminal illness.

In addition, your MetLife coverage provides online Will service preparation at WillsCenter.com, available to you at no charge.
